

### ARTICLES OF INCORPORATION

# SUNSET CONDOMINIUMS AT NORTHERN BAY OWNERS ASSOCIATION, INC.

Sunset Condominiums at Northern Bay Owners Association, Inc., a nonstock, nonprofit corporation organized under Chapter 181 of the Wisconsin Statutes, hereby adopts the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation is Sunset Condominiums at Northern Bay Owners Association, Inc. (hereinafter referred to as the "Association").

### ARTICLE II PERIOD OF EXISTENCE

The period of existence of the Association is perpetual.

# ARTICLE III PURPOSE

The Association is organized to serve as an association of unit owners (as described in Section 703.15 of the Wisconsin Statutes) for Sunset Condominiums at Northern Bay, a condominium created under Chapter 703 of the Wisconsin Statutes, located in the Town of Strongs Prairie, Adams County, Wisconsin, and to exercise the powers, carry out the responsibilities, and otherwise engage in any lawful activity authorized and permitted by Chapter 181 of the Wisconsin Statutes.

### ARTICLE IV MEMBERS

The Association shall have members. Membership provisions (including the designation of classes, if any, and the method of acceptance of members of each such class) shall be set forth in the Bylaws of the Association (the "Bylaws"). The respective voting rights of the members of the Association shall be as set forth in the Bylaws and that certain Declaration of Condominium for Sunset Condominiums at Northern Bay recorded in the office of the Adams County Register of Deeds (the "Declaration").
